What information do we collect about you?

Information you give to us: In order to process your subscription to *Funeral Director* Monthly magazine, it is necessary to collect personal data from you. This includes, but is not limited to, your name, address, e-mail address, telephone number, credit/debit card information. We are unable to provide you with a subscription if you do not provide certain information to us.

How will we use the information about you?

We will use your information for the following purposes:-

- 2) to process and deliver your subscription, including within any mailing list provided to the publisher's mailing house;
- 3) to manage payments, fees and charges;
